Main Street Approach

Main Street Portsmouth is a 501 (c) 3 nonprofit seeking to revitalize downtown Portsmouth and historic Boneyfiddle. MSP uses the approach begun by the National Main Street program in 1977.

Main Street is a community-driven economic development program created by the National Trust for Historic Preservation which focuses on four specific areas: Design, Promotion, Organization and Economic Restructuring.

The Main Street approach has successfully revitalized downtowns in over 1,600 communities nationwide, generating over 16 billion dollars of re-investment in those communities.

Vendors License

Before making any commitments to do business in Portsmouth, contact the City Engineering Department. They will help you determine if your proposed business meets zoning regulations, and you will have a much clearer picture of what lies ahead. Next, apply for a vendor's license with the Scioto County Auditor's office.

Building Permits

If you are making any structural, electrical, plumbing, or mechanical changes to your facility, submit a Building Permit application to the City Engineering Department. Alterations to the exterior of a building may be subject to approval from the Design Review board.

Design Review

All new and exterior building renovations and signage within the Historic Boneyfiddle District and Downtown Improvement District require design review approval. Contact the City Engineering Department and allow sufficient time in your business plan for this process.

Restaurant/Food Related Permits

If your business involves selling or handling food, a permit from the City Health Department may be needed. Improvements and/or inspections of the building and facilities may also be needed.

Demolition Permits

For all structural demolition, contact the City Health Department. This department will determine any health related issues. Once the Health Department signs off on any health related issues, apply for a Demolition Permit from the City Engineering Department.

FUNDING YOUR BUSINESS

One key to any successful business start-up is the ability to secure appropriate financing. Armed with the right information and a good business plan, you can navigate the process in a timely and successful fashion. Both the SBDC and CAC of Pike County can guide you through the business plan process and give valuable information about funding options.

Check with your local bank and inquire about commercial lending opportunities. "Gap Lending" may be available when 100% financing cannot be secured in a traditional manner.
